

# Proposed Changes to Planning Controls for Penrith Panthers Site

**FACT SHEET** 

### **Background**

Council has received a request to change the planning controls applying to the Penrith Panthers Site (Figure 1). The Penrith Panthers Site can currently be developed with a range of tourism related uses (including hotels, motels and serviced apartments), residential apartments, seniors housing, offices, and shops including an outlet centre (a building or place containing one or more shops selling surplus goods, seconds, samples, discontinued stock etc).

The intention of the proposed changes is to enable the development of a mixed-use and residential precinct on the northern portion of the Penrith Panthers Site.

The development of the site with new apartments is considered a good opportunity to provide additional homes in a location that has good access to jobs, shops and services provided by the City Centre, as well as nearby leisure and entertainment facilities.

The changes will also allow the development of taller buildings (up to 14 storeys) in the centre of the site and reduce the height of buildings in locations next to existing development, such as the Mountain View Retreat Retirement Village. Allowing taller buildings in appropriate locations provides opportunities for an attractive and interesting development, and shorter buildings next to existing development helps reduce overshadowing and amenity impacts.

### **Have Your Say**

The process that Council must follow to consider this request, known as the Gateway Process, requires the public exhibition of a Planning Proposal. A Planning Proposal is a document that explains and justifies the proposed changes to the planning controls.

Council also proposes an amendment to a Development Control Plan. A Development Control Plan provides detailed controls and design guidelines to support the planning controls.
