DRAFT AMENDMENT TO DEVELOPMENT CONTROL PLAN 2014 FACTSHEET

BACKGROUND

Council has prepared a Draft Amendment to the Penrith Development Control Plan 2014 (DCP). The proposed changes relate to the Oakdale South Industrial Estate, Proposed Road Patterns, and Council's adopted Stormwater Drainage Specification for Building Developments policy. The draft is currently on public exhibition and Council invites the public to inspect and comment on the draft.

OAKDALE SOUTH INDUSTRIAL ESTATE (OSIE)

The existing DCP contains controls that guide development in Erskine Business Park. OSIE is within Erskine Business Park. A State Significant Development Application was approved by the NSW Minister for Planning that includes variations to the existing DCP controls relating to subdivision, site development and urban design, and car parking. The intention of the draft is to align the DCP with the SSDA and provide consistency of the built form across the site.

PROPOSED ROAD PATTERNS

The DCP contains chapters which require half road construction and dedication of land at locations in Emu Plains, Kingswood and St Marys.

The proposed DCP changes are intended to ensure development of the land is consistent with the proposed road patterns. It is proposed to insert new controls which provide for dual frontage and fencing requirements, reduce landscape area requirements, and remove road patterns which are no longer required.

STORMWATER DRAINAGE SPECIFICATION FOR BUILDING DEVELOPMENTS POLICY

Council adopted this policy (available on our website) in November 2016 to clarify stormwater drainage requirements for building development. The proposed changes will update references and information in the DCP to be consistent with this policy.
