

RECLASSIFICATION OF PUBLIC LAND IN ST MARYS TOWN CENTRE

ADDRESSING THE PUBLIC HEARING

OVERVIEW

Council is proposing a change to the classification of certain public land in St Marys Town Centre from Community to Operational. The reason for the proposal is to prepare the land to allow Council and the community to consider wide opportunities to grow the Town Centre (including new development) that implement the adopted St Marys Town Centre Strategy (2006). The proposal was placed on public exhibition between Monday 24 August and Monday 21 September 2015. The exhibition material remains available to view online or at Penrith Civic Centre. The process Council must follow to exhibit and consider the proposal also requires us to hold an independently chaired public hearing. The chair of the hearing will then provide Council with a report on the hearing, which will also be made public.

The **hearing** will commence at **5:30pm** on **Wednesday 21 October 2015** at **St Marys Corner Community and Cultural Precinct**. There may be additional sessions arranged depending on the number of people who wish to address the hearing.
