

ANNUAL UPDATE AMENDMENT PLANNING PROPOSAL

FACT SHEET

THE PLANNING PROPOSAL

A Planning Proposal is a document that explains and justifies changes being proposed to planning controls.

The NSW Department of Planning & Environment process requires any planning proposal to go on public exhibition for community comment before it can be adopted.

WHAT CHANGES ARE PROPOSED?

The intention of the changes being proposed is to resolve several policy changes, contemporise certain elements and undertake "housekeeping" changes which are minor in nature. These matters have been consolidated as a single set of proposed changes to Penrith Local environmental Plan 2010, known as an "Annual Update Amendment".

BENEFITS

Resolving these matters will provide a more accurate planning instrument and reduce the potential for delays, should development be proposed where the identified matters exist.

HAVE YOUR SAY

We're now seeking your feedback on the proposed changes. The Planning Proposal is on public exhibition from 15 April to 27 May 2019.
