Erskine Park Road Upgrade

Community Consultation Report

March 2017



Executive summary

This report provides a summary of the community consultation carried out by Penrith City Council in November and December 2016 on a proposal for intersection improvements along Erskine Park Road, Erskine Park.

The Australian Government is funding a \$200 million Local Roads Package as part of the Western Sydney Infrastructure Plan to improve road safety and traffic flow efficiency. Key intersection upgrades along Erskine Park Road, Erskine Park are part of this funding. The key features of the proposed upgrade include:

- Erskine Park Road and Bennett Road upgrade the intersection and install new traffic signals
- Erskine Park Road and Peppertree Drive upgrade the existing intersection to a new seagull intersection
- Erskine Park Road and Coonawarra Drive upgrade the existing intersection to a new seagull intersection
- Erskine Park Road & Explorers Way upgrade the intersection and install new traffic signals
- Erskine Park Road between Coonawarra Drive and Bennett Road upgrade to four lane median separated dual carriageway (two lanes in each direction) and a new shared user path.

At the completion of the Erskine Park Road Upgrade, Erskine Park Road will be widened to a four lane dual carriageway between Bennett Road and Explorers Way to join the existing four lane sections towards the M4 Motorway and Swallow Drive.

Letters have been distributed to the community and stakeholders in the local area, inviting feedback.

Penrith Council received 20 comments from 14 people with 11 about design, four about parking, one about traffic signals, three about noise and vibration, and one about environmental impacts.

Penrith City Council will provide responses to all feedback through this report and directly to members of the community and stakeholders who have made comments.

We would like to take this opportunity to thank everyone for considering our proposal and providing comments.

Penrith City Council has reviewed all feedback and is proceeding with the detailed design of the proposed intersection improvements along Erskine Park Road, Erskine Park.

Construction is expected to start late 2017 and we will keep the community updated as this project progresses.

1. Introduction

1.1. Background

Erskine Park Road is located in the Penrith City Council Local Government Area (LGA). Erskine Park Road has a combination of two and four lane road configurations, running north-south and connecting the M4 Motorway to Mamre Road and providing access to the suburbs of St Clair and Erskine Park. The M4 Motorway is located about 280 metres north of the proposal. Where there are two lanes in each direction, a raised median separates the northbound and southbound carriageway. Explorers Way, Coonawarra Drive, Peppertree Drive and Bennett Road all form intersections with Erskine Park Road, which are all not currently signalised.

1.2. The Proposal

The Australian Government is funding a \$200 million Local Road Package as part of its \$3.6 billion Western Sydney Infrastructure Plan, to be completed over the next 10 years to improve road safety and traffic flow efficiency on Sydney's major roads.

The Local Roads Package includes a proposal to upgrade four intersections along Erskine Park Road, Erskine Park and to improve turning lanes from Erskine Park Road:

- Erskine Park Road and Bennett Road upgrade the intersection and install new traffic signals
- Erskine Park Road and Peppertree Drive upgrade the existing intersection to a new seagull intersection
- Erskine Park Road and Coonawarra Drive upgrade the existing intersection to a new seagull intersection
- Erskine Park Road & Explorers Way upgrade the intersection and install new traffic signals
- Erskine Park Road between Coonawarra Drive and Bennett Road upgrade to four lane median separated dual carriageway (two lanes in each direction) and a new shared user path.

The extent of works will include 200m from each intersection along Erskine Park Road state road corridors and 100m to all side streets.



2. Consultation Approach

2.1 Consultation Objectives

We consulted with the community during November and December 2016 to:

- Seek comment, feedback, ideas and suggestions for us to consider when developing the detailed design.
- Build a database of interested and concerned community members with whom we can continue to engage during the proposal's development.

2.2 How Consultation was done

We sought feedback between 25th November 2016 and 23rd December 2016. Community members and stakeholders were encouraged to provide their feedback and make comments via mail, email or phone contact with the project team. Our consultation tools included:

3. Consultation Summary

3.1. Overview

Penrith Council received twenty comments from fourteen people. Eleven comments were about design, four about parking, one about traffic signals, three about noise and vibration, and one comment was about environmental impacts.

	Suggestion to close the right hand turn lane from Coonawarra Drive, and to create a pedestrian refuge facility for pedestrians crossing Coonawarra Drive at this intersection.	The suggestions will be assessed during the appropriate review stages in the design process.
	Upgrading the section of road between Bennett Road and Lenore Drive should also be done.	Funding is only approved for current intersections as part of the Round 2 funding agreement.
	(NOTE: this section is outside of the Project scope.)	Penrith Council is likely to recommend the omitted section in the next round of funding for Round 3 funding.
	Request for the laneway on Omega Place, Erskine Park, to be permanently closed.	This designated laneway may not be able to be permanently closed, however, further investigation into the matter will be undertaken by the design team.
	Inquiry on future plans to create Westbound ramps at the M4 Roper Road interchange (NOTE: this section is outside of the Project scope)	The M4 motorway is funded and directly managed through Roads and Maritime Services (RMS), not council. The RMS are currently looking into upgrading existing ramps for the M4 Smart Motorway project, but the inclusion of missing ramps may not be in this scope.
	Suggestion that a roundabout would prove more effective than a seagull intersection for both	Erskine Park Road is an approved B-Double truck route, with Penrith Council's designer confirming that not enough space is available for the roundabout to cater for such vehicles.



	Coonawarra Drive and Peppertree Drive.	Unfortunately, this space can only be achieved through the acquisition of private property.
		As suggested in the traffic modelling study, traffic will predominately use the Bennett Road traffic signals instead of Coonawarra Drive, as the traffic signals will make it easier to use.
		In addition, a seagull intersection is more cost effective if future upgrading to traffic signals is required.
Parking 4 Comments	No Parking zone will cause visitors to walk a further distance than usual.	The designer will look into limited "No Parking" areas to peak times only where practicable, with restrictions similar to those at the Banks Drive traffic signals.
	Loss of parking can cause inconvenience for support services such as medical home visits.	The residents will be notified of the outcome in relation to modifying the parking restrictions in order to access services.
	Suggested timing restrictions to compensate for the loss of parking on Coonawarra Drive.	The design team will further investigate the issue to minimise associated impacts to residents, such as exploring the benefits of creating parking restrictions during peak times and reducing the proposed turn lane length.
Traffic Signals 1 Comment	Concerns over Southbound approach on Bennett Road in relation to heavy vehicle drivers, braking distances and traffic signal compliance Suggestion for the installation of flashing lights to provide adequate warning to heavy vehicle drivers.	The traffic signal manual mentions that flashing lights to advance warning where flashing lights are obscured by road geometry can be appropriate, however, they should be restricted to locations where they have the highest potential for crash reduction and provoke consistent driver reaction. Inclusion of advanced warning will be based on if sight and braking distances has been adequately catered for B-Doubles.
		RMS and Police will be required to enforce operational compliance issues, such as heavy vehicles intentionally and illegally running a red light.
Noise & Vibration	Suggestions of the road being lowered and the creation of a solid barrier parallel to the back fences of bouses along this road to	A noise and vibration assessment will be commissioned, and noise treatments will be provided in accordance with RMS Noise
3 Comments	of houses along this road to lessen associated noise.	Mitigation Guidelines if properties meet the relevant threshold criteria.

- Erskine Park Road between Coonawarra Drive and Bennett Road upgrade to four lane median separated dual carriageway (two lanes in each direction) and a new shared user path

At the completion of the Erskine Park Road Upgrade, Erskine Park Road will be widened to a four lane dual carriageway between Bennett Road and Explorers Way to join the existing four lane sections towards the M4 Motorway and Swallow Drive.
