Community Consultation Report

March 2017

Executive summary

This report provides a summary of the community consultation carried out by Penrith City Council in November 2016 and January 2017 on a proposal for intersection improvements along The Northern Road (Parker Street).

The Australian Government is funding a \$200 million Local Roads Package as part of the Western Sydney Infrastructure Plan to improve road safety and traffic flow efficiency. Intersection upgrades on The Northern Road at Derby Street, Kingswood and The Great Western Highway, Kingswood are part of this funding. The key features of the proposed upgrade include:

Derby Street and The Northern Road intersection

- New designated left and right turn lanes on both Derby Street approaches
- Adjustments to kerb lines and footpaths
- Removal of some on-street parking on Derby Street to facilitate these additional turning lanes
- Relocation of bus stops to facilitate turning lanes

The Great Western Highway and The Northern Road intersection

- 50m extension of the right turn lane northbound on The Northern Road
- 100m extension of the right turn lane westbound on the Great Western Highway
- Widening of the right turn lane and realignment of median island, southbound on The Northern Road
- New pedestrian fencing in the median island of The Great Western Highway

Letters have been distributed to the community and stakeholders in the local area, inviting feedback.

Penrith Council received feedback from three community members and stakeholders. Five comments were about the community and one was about parking.

Penrith Council will provide responses to all feedback through this report and directly to members of the community and stakeholders who have made comments.

We would like to take this opportunity to thank everyone for considering our proposal and providing comments.

Penrith Council has reviewed all feedback and is proceeding with the detailed design of the proposed intersection improvements to The Northern Road (Parker Street) at Derby Street and The Great Western Highway.

Construction is expected to start late 2017 and we will keep the community updated as this project progresses.

1. Introduction

1.1. Background

The Northern Road is an arterial road running north / south between Windsor and Narellan via Penrith that will ultimately form one of the main arterial transport corridors to the South West Growth Centre (SWGC) and the Western Sydney Employment Area (WSEA). Intersections along The Northern Road between the Great Western Highway and the M4 Western Motorway are currently operating at capacity. As a result of the increasing population and employment growth and changes in land use, traffic flow efficiency, travel time and road user safety will continue to decline. The proposed works would address these issues at the selected intersections, Derby Street and The Great Western Highway, along The Northern Road.

1.2. The Proposal

The Australian Government is funding a \$200 million Local Road Package as part of its \$3.6 billion Western Sydney Infrastructure Plan, to be completed over the next 10 years to improve road safety and traffic flow efficiency on Sydney's major roads.

As part of the Local Roads Package, two intersections along The Northern Road will be upgraded:

Derby Street and The Northern Road intersection

- New designated left and right turn lanes on both Derby Street approaches
- Adjustments to kerb lines and footpaths
- Removal of some on-street parking on Derby Street to facilitate these additional turning lanes
- Relocation of bus stops to facilitate turning lanes

The Great Western Highway and The Northern Road intersection

- 50m extension of the right turn lane northbound on The Northern Road
- 100m extension of the right turn lane westbound on the Great Western Highway
- Widening of the right turn lane and realignment of median island, southbound on The Northern Road
- New pedestrian fencing in the median island of The Great Western Highway

The extent of work will include 200m from each intersection on The Northern Road, 100m along all side streets except The Great Western Highway which is 200m in each direction.

2. Consultation Approach

2.1 Consultation Objectives

Penrith Council consulted with the community during November 2016 and January 2017 to:

- Seek comment, feedback, ideas and suggestions to consider when developing the detailed design.
- Build a database of interested and concerned community members with whom Council can continue to engage during the proposal's development.

2.2 How Consultation was done

Council sought feedback between 28 November 2016 and 27 January 2017. Community members and stakeholders were encouraged to provide their feedback and make comments via mail, email or phone contact with the project team. Consultation tools included:

3. Consultation Summary

3.1. Overview

Penrith Council received six comments from three people. Five comments were about the community and one was about parking.

Have your say – The Northern Road (Parker Street) intersection improvements at Derby Street and The Great Western Highway

The Australian Government is funding a \$200 million Local Roads Package as part of the Western Sydney Infrastructure Plan. Funding has now been allocated to Penrith City Council to improve road safety and traffic flow efficiency at key intersections along The Northern Road.

The project is now progressing to final design. Council is inviting community feedback on the concept design and Review of Environmental Factors for the project.

Key features of the proposed upgrade

Derby Street and The Northern Road intersection

- · New designated left and right turn lanes on both Derby Street approaches.
- · Adjustments to kerb lines and footpaths
- Removal of some on-street parking on Derby Street to facilitate these additional turning lanes
- · Relocation of bus stops to facilitate turning lanes

The Great Western Highway and The Northern Road intersection

- · 50m extension of the right turn lane northbound on The Northern Road
- 100m extension of the right turn lane westbound on the Great Western Highway
- Widening of the right turn lane and realignment of median island, southbound on The Northern Road
- · New pedestrian fencing in the median island of The Great Western Highway

The upgrades will significantly improve road safety and traffic efficiency.

What are the next steps?

- · Council is currently inviting community feedback
- Detailed Design starting early 2017
- Construction starting late 2017

The community will be kept informed as the project progresses.

During construction, there will be additional temporary loss of parking that will occur on The Northern Road and Great Western Highway. Two lanes in either direction on The Northern Road and Great Western Highway will be in operation at peak times.
